In the training, we introduce core concepts and theories of board governance and use practical examples and case studies to engage participants in decision-making. You will understand what boards are, how they operate, and what the roles and responsibilities of board members are.

The programme will not only prepare you for board roles in corporations but also for non-profit organisations, where you can develop your leadership while contributing to social causes that align with your personal value and belief.

This training is designed for those wishing to enhance their leadership skills by learning what it takes to sit on a company board (whether for- or not-for-profit). Past participants range from professionals preparing for their first step into management right up to C-suite executives who have years of experience leading whole organisations.

Considers the board's role in managing risks, particularly from a long-term strategy standpoint.

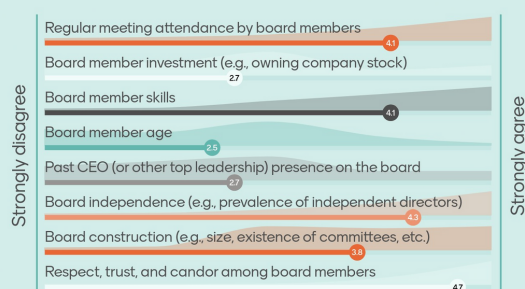

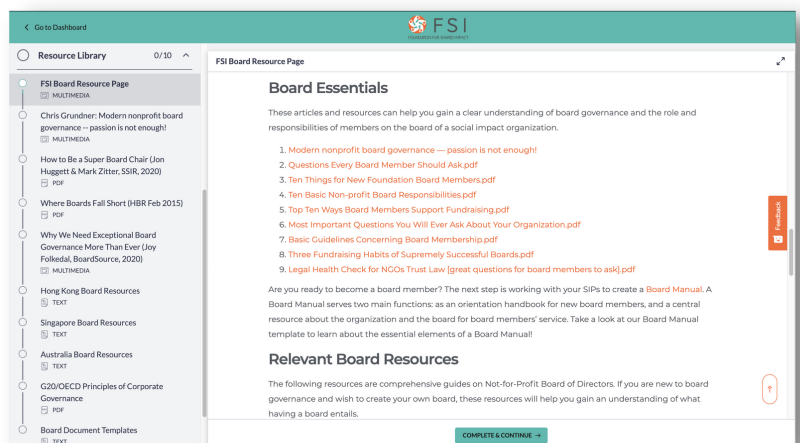


What makes boards great?
